INVITATION TO BID

**JOINT VENTURE OPERATION ON THE DESIGN AND BUILDING/CONSTRUCTION
OF A WASTE PROCESSING FACILITY (THROUGH GARABAGE CONVERSION TO
ELECTRICITY TECHNOLOGY-GCtE) IN OLONGAPO CITY SANITARY LANDFILL**

The City Government of Olongapo (CGO) received an unsolicited proposal for the Design and Building/Construction of a Waste Processing Facility (through Garbage Conversion to Electricity Technolog-GCtE) in Olongapo City Sanitary Landfill with an aggregate area of more or less fifteen (15) hectares.

Pursuant to Section 18 of City Ordinance No. 04, Series of 2019, otherwise known as the "Olongapo P4 Code", invites the public, through its PPP-SC, to submit their bids and their comparative proposals for competitive or Swiss challenge.

The bids and comparative proposals shall be subject to the terms and conditions prescribe in the TOR prepared by the PPP-SC. The TOR will be available only to prospective bidders upon payment of a non-refundable amount of Fifty Thousand Pesos (P50,000.00) with the PPP-SC Office of the CGO. Only those who have paid the non-refundable fee shall be allowed to participate in the pre-bidding conference and bidding process.

The CGO reserves the right to reject any of all bids, declare failure of bidding and not to award the contract for any justifiable and reasonable grounds where an award will not redound to the benefit of the City.

The CGO shall immediately award to the Original Proponent (OP) if no expression of interest or comparative proposal receive until November 4, 2019.
